## BID EVALUATION CRITERION FOR 72 PROCESSOR CLUSTER

Bid evaluation criterion is "economically most favorable bid". Bid ranking and evaluation will be carried out according to the criteria rated as per following number of points:

### 1. Price

50 points

In order to calculate the number of points for the offered price, the following formula will be applied:

$$\frac{\textit{The most favorable offered price}}{\textit{Offered price}} \times 50$$

(The results will be rounded per mathematical rules to the second decimal figure).

### 2. Warranty period

15 points

The bidder is expected to state the length of warranty period according to the following items:

- a) Node computers (NR)
- b) Switch + LAN Ethernet adaptor + Stack interface (SLS)
- c) Server (SRV)
- d) Other equipment (O)

The points scored by this criterion will be calculated according to the following formula:

$$\frac{NR}{MAX_{NR}} * 5 + \frac{SLS}{MAX_{SLS}} * 5 + \frac{SRV}{MAX_{SRV}} * 3 + \frac{O}{MAX_{O}} * 2$$

where MAX indicates maximum offered length of warranty period for each item.

### 3. Payment terms

10 points

In order to calculate the number of points for offered payment terms, the following formula will be applied:



$$10 - 10 \frac{\% \text{ advance payment}}{100}$$

#### **4. Service** **15 points**

For this criterion, the response time upon call or the repair time will be compared.

##### ***a) Response time upon call*** **5 points**

(arrival of servicing agent on the spot)

- up to one hour sat **5 points**
- up to two hours **3 points**
- up to five hours **1 point**
- over five hours **0 points**

##### ***b) Repair time*** **10 points**

- up to twelve hours **10 points**
- up to twenty four hours **6 points**
- up to forty eight hours **3 points**
- over forty eight hours **0 points**

#### **5. Delivery time** **10 points**

For this criterion, the lengths of delivery time will be compared.

##### ***a) for Node computer, server, LAN Ethernet adaptor and other equipment*** **7 points**

- up to 7 days from contract signing **7 points**
- up to 15 days from contract signing **3 points**
- up to 30 days from contract signing **1 point**
- over 30 days from contract signing **0 points**

##### ***b) for Swiths and stack interface*** **3 points**

- up to 4 weeks from contract signing **3 points**
- up to 6 weeks from contract signing **2 points**



- up to 8 weeks from contract signing **1 point**
- over 8 weeks from contract signing **0 points**

**If during ranking or evaluating, two or more bids have the same number of points, the contract will be assigned to the bidder offering the lowest price.**

## **BID EVALUATION CRITERION FOR SOLAR LIGHT SIMULATOR**

Bid evaluation criterion is "economically most favorable bid". Bid ranking and evaluation will be carried out according to the criteria rated as per following number of points:

### **1. Price 50 points**

In order to calculate the number of points for the offered price, the following formula will be applied:

$$\frac{\text{The most favorable offered price}}{\text{Offered price}} \times 50$$

(The results will be rounded per mathematical rules to the second decimal figure).

### **2. Technical and technological characteristics 30 points**

Bid fulfillment in % x 30

Bid fulfillment in % is determined through estimation of bid deviation from the requirements by deducting a percent for each key characteristic of the equipment which does not comply with the request, or for unfulfillment of any characteristics stated in technical specification, by deducting 10% out of possible 100%.

### **3. Delivery date 10 points**

For this criterion, the lengths of delivery date will be compared by application of the following formula:



$$\frac{\textit{The least offered time limit}}{\textit{Offered number of delivery days}} \times 10$$

#### **4. Warranty period**

**10 points**

For this criterion, the lengths of warranty period will be compared by application of the following formula:

$$\frac{\textit{Offered number of warranty period days}}{\textit{The most suitable warranty period days}} \times 10$$

**If during ranking or evaluating, two or more bids have the same number of points, the contract will be assigned to the bidder offering the lowest price.**

#### **BID EVALUATION CRITERION FOR “LAW VALUES” EQUIPMENT**

According to the Law on public procurements, since the price of these equipment units is below 2.500.000,00 (30.864 EUR) then purchase will be done through the procedure related to procurements of low values.

**In this case only criterion is the price. The bid with the lowest price, which is in accordance with prices indicated in Annex I – Description of work, will be accepted.**
